### 1. Independent Contractor Status

The Contractor acknowledges and agrees that they are an independent contractor and not an employee of the Company. The Contractor shall have no authority to bind the Company or represent themselves as an employee or agent.

### 2. Scope of Services

The Contractor agrees to provide roadside assistance services, including but not limited to:

- Battery jump-starts.
- Tire changes.
- Lockout services.
- Fuel delivery.
- Basic roadside diagnostics.

The Contractor will perform services using their own tools, equipment, and vehicle.

## 3. Compensation

The Company agrees to pay the Contractor as follows:

- Carrying comprehensive general liability and automobile insurance with limits not less than State Standard.

Proof of insurance and licensing must be provided to the Company upon request.

#### 5. Service Area

The Contractor agrees to operate within the designated service area as outlined in **Schedule A**. Travel outside this area will require prior approval.

#### 6. Performance Standards

The Contractor agrees to:

- Respond to service requests promptly, typically within [XX] minutes.
- Conduct themselves professionally and courteously with all customers.
- Ensure services are performed to a high standard of quality and safety.

### 7. Expenses

The Contractor shall be responsible for all expenses incurred in connection with the performance of services, including fuel, tools, vehicle maintenance, and insurance.
